

Nominating Committee

The Nominating Committee is responsible for presenting a slate of nominees to the church for election.

As a member of River Road Church, Baptist, the Nominating Committee wants to give you the opportunity to join in the leadership and service of your church. Prayerfully consider your interests, gifts and talents and return your selections to the church office.

Boards and Councils

- Board of Administration**—The Board of Administration is instructed by the church constitution to manage the financial responsibilities, property, and facilities of the church.
- Board of Deacons**—The Board of Deacons assists the ministerial staff in support of the congregation and of worship in a number of ways. Their duties include outreach to the membership through care groups; hosting of the after church coffees; support during worship through greeting members, taking up the offering, and serving communion. The board also administers the Fellowship Fund which offers financial support to members of the local community.
- Board of Missions**—The Board of Missions is responsible for promoting service by the church, its organizations, and individual members. It develops and implements programs and projects of gift, service, and Christian outreach in cooperation with mission fellowships in the church, community service organizations, and national and worldwide affiliations.
- Board of Christian Education**—As an expression of love and service for God, the Board of Christian Education promotes, facilitates and nurtures lifelong learning and growth in faith for the River Road Church community through educational ministries.
- Building and Property Council**—The Building and Property Council has the responsibility for and oversight of all planning and construction of the buildings and grounds including all major alterations.

Committees

- Arts**—The committee plans and coordinates all activities for children, youth and adults.
- Audit**—The committee conducts an annual audit process for the financial activities of the Church and Preschool Development Center.
- Baptism**—The committee assists the pastor and church staff in the preparation and conduct of all services of baptism.
- Chancel**—The Chancel Committee is responsible for providing and arranging the paraments, flowers, candles, and decorations of the Sanctuary and Chapel for each Sunday worship service and for all special services in the church, including weddings and funerals.
- Columbarium Memorial Garden**—The committee oversees the operational matters of the Columbarium Memorial Garden.
- History**—The committee is responsible for the preservation, organization and safe storage of all records not in current use.
- Lord's Supper**—The committee prepares the elements and arranges the communion table, linens, and communion silver for all services.
- Music**—The music committee oversees all of the music programs of the church including the River Road Church Concert Series, the various children and adult choirs, the children and adult bell choirs and the summer music camp.
- Nominating**—This committee is responsible for filling the various committee positions.
- Preschool Development Center**—This committee works with Preschool Director, Margaret Collins and her staff to ensure the positive and effective operation of the Preschool Development Center.
- Publicity**—The committee assists the church staff in publicizing the ministries and programs of the church.
- Recreation**—The recreation committee plans and sponsors various recreational activities throughout the year for members of all ages.
- Social**—The committee arranges and coordinates all social activities as requested by the church staff.
- Transportation**—The committee shall be responsible for the recruitment, training, and scheduling of drivers of both church and personal vehicles to provide transportation for church members to church services, programs and activities.
- Ushers**—The committee recruits, trains, and coordinates ushers for all services of worship.
